Commencing at a found iron rod marking the south quarter post of said Section 36;

thence on an assumed bearing of N 00° 03' 52" E along the north-south half section line  
of said Section 36 a distance of 1626.68 feet to a set iron rod and being the **POINT OF  
BEGINNING** of the hereinafter described parcel;

thence continuing N 00° 03' 52" E along the north-south half section line of said Section  
36 a distance of 846.00 feet to a set iron rod marking a corner of a parcel of land now or  
formerly owned by S. Goble, Etal.;

thence N 89° 57' 42" E along said S. Goble, Etal. parcel a distance of 180.04 feet to a  
found iron rod marking a corner of said S. Goble, Etal. parcel, passing a found iron rod a  
distance of 5.04 feet;

thence S 00° 02' 13" E on a line a distance of 400.00 feet to a set iron rod;

thence S 89° 35' 17" E on a line a distance of 174.93 feet to set iron rod;

thence S 20° 24' 32" E on a line a distance of 123.27 feet to a set iron rod;

thence S 38° 21' 14" E on a line a distance of 153.89 feet to a set iron rod;

thence S 00° 35' 46" W on a line a distance of 190.67 feet to a set iron rod;

thence S 87° 54' 32" W on a line a distance of 493.00 feet to the **POINT OF  
BEGINNING**.

Containing in all 6.164 acres of land, more or less. The above described property being  
subject to all legal highways and easements of record.
