SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, VILLAGE OF NEVADA, BEING PART OF OUT LOT 1 OF GOODBREAD WELSH AND DOMBAUGH'S ADDITION, AS SHOWN AND DELINEATED IN PLAT BOOK 1, PAGE 53, BEING A 0.794 ACRE TRACT CONVEYED TO THOMAS J. CRAWFORD AND ASHLEIGH STEVENS OF RECORD IN OFFICIAL RECORD 280, PAGE 1234, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT AN IRON PIN SET ON THE SOUTH RIGHT- OF-WAY LINE OF DOMBAUGH STREET (40 FEET IN WIDTH), A NORTHWEST CORNER OF SAID OUT LOT 1, A NORTHWEST CORNER OF SAID CRAWFORD TRACT, AND A NORTHEAST CORNER OF A TRACT CONVEYED TO LARRY M. ROSS OF RECORD IN DEED VOLUME 194, PAGE 746;


