**LEGAL DESCRIPTION OF A 0.907 ACRE PARCEL
FOR RELCO, LLC**

Being a parcel of land situated in part of the Southeast Quarter of Section 19, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the southeast corner of said Section 19;

thence on an assumed bearing of S 89° 58' 45" W along the south line of said Section 19 a distance of 1326.69 feet to a point marking the west line of the east half of the southeast quarter of said Section 19, passing a found iron rod a distance of 1321.69 feet;

thence N 00° 02' 09" E along the west line of the east half of the southeast quarter of said Section 19 a distance of 427.11 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence S 88° 41' 38" W on a line a distance of 143.74 feet to a set iron rod;

thence N 00° 58' 33" E on a line a distance of 189.41 feet to a set iron rod;

thence N 37° 37' 20" E on a line a distance of 230.50 feet to set iron rod marking the west line of the east half of the southeast quarter of said Section 19;

thence S 00° 02' 09" W along the west line of the east half of the southeast quarter of said Section 19 a distance of 368.67 feet to the **POINT OF BEGINNING**.

Containing in all 0.907 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
