**LEGAL DESCRIPTION OF A 3.071 ACRE PARCEL

Being a parcel of land situated in part of the Northeast Quarter of Section 36, T-2-S, R-14-E, Eden Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the northeast corner of said Section 36 and the centerline of County Highway 128;

thence on an assumed bearing of S 00° 25' 27" E along the east line of said Section 36 and the centerline of said County Highway 128 a distance of 496.00 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated S 89° 34' 33" W a distance of 20.00 feet;

thence continuing S 00° 25' 27" E along the east line of said Section 36 and the centerline of said County Highway 128 a distance of 490.00 feet to a set MAG nail;

thence S 89° 34' 33" W on a line a distance of 75.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 21° 43' 51" W on a line a distance of 214.37 feet to a set iron rod;

thence N 88° 16' 57" W on a line a distance of 233.00 feet to set iron rod;


thence N 00° 28' 44" W on a line a distance of 281.58 feet to a set iron rod;

thence N 89° 34' 33" E on a line a distance of 386.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 366.00 feet

Containing in all 3.071 acres of land, more or less, of which 0.225 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
