CITY OF UPPER SANDUSKY, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, CITY OF UPPER SANDUSKY, AND BEING PART OF HIGHLAND ACRES SUBDIVISION NO. 8, LOT 6 AND BEING A 6.097 ACRE TRACT CONVEYED TO MJ DIVERSIFIED, GP, LLC., OF RECORD IN OFFICIAL RECORD 285, PAGE 2167, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT AN IRON PIN FOUND AT THE SOUTHWEST CORNER OF A HIGHLAND ACRES SUBDIVISION NO. 8, LOT 6, THE SOUTHWEST CORNER OF SAID MJ DIVERSIFIED TRACT, AND A SOUTHEAST CORNER OF A TRACT CONVEYED TO CRAWFORD PLACE LIMITED PARTNERSHIP OF RECORD IN OFFICIAL RECORD 213, PAGE 1183;

THENCE SOUTH 10°06'12" WEST, A DISTANCE OF 278.89 FEET WITH AN EAST LINE OF SAID LOT 6, AN EAST LINE OF SAID MJ DIVERSIFIED TRACT, A WEST LINE OF SAID LOT 7, A WEST LINE OF SAID M C DIVERSIFIED TRACT, AND A WEST LINE OF A TRACT CONVEYED TO THE CITY OF UPPER SANDUSKY OF RECORD IN OFFICIAL RECORD 225, PAGE 1536; , TO AN IRON PIN FOUND AT A SOUTHEAST CORNER OF SAID LOT 6, A SOUTHEAST CORNER OF SAID MJ DIVERSIFIED TRACT, A WESTERLY CORNER OF SAID LOT 7, A WESTERLY CORNER OF SAID CITY OF UPPER SANDUSKY TRACT, AND A NORTHEAST CORNER OF THE FREE AREA NO. 7 AS SHOWN AND DELINEATED ON HIGHLAND ACRES NO. 7;

THENCE SOUTH 89°20'17" WEST, A DISTANCE OF 78.85 FEET WITH THE SOUTH LINE OF SAID LOT 6, THE SOUTH LINE OF SAID MJ DIVERSIFIED TRACT, AND THE NORTH LINE OF SAID FREE AREA NO. 7, TO AN IRON PIN SET AT A NORTHEAST CORNER OF LOT 21 OF HIGHLAND ACRES NO. 7 AND ALSO AN EAST LINE OF A TRACT CONVEYED TO DAN A. AND REBECCA A. NEWELL OF RECORD IN OFFICIAL RECORD 255, PAGE 1740 AND OFFICIAL RECORD 255, PAGE 1739, AND A SOUTHWEST CORNER OF SAID MJ DIVERSIFIED TRACT;

THENCE NORTH 00°39'43" WEST, A DISTANCE OF 22.96 FEET WITH A WEST LINE OF SAID MJ DIVERSIFIED TRACT AND AN EAST LINE OF SAID NEWELL TRACT, TO AN IRON PIN SET;

THENCE SOUTH 89°20'18" WEST, A DISTANCE OF 149.53 FEET WITH A SOUTH LINE OF SAID MJ DIVERSIFIED TRACT AND A NORTH LINE OF SAID NEWELL TRACT, TO AN IRON PIN SET ON THE EAST RIGHT-OF-WAY LINE OF GREENBRIER ROAD (50 FEET IN WIDTH), A WEST LINE OF SAID LOT 6, A SOUTHWEST CORNER OF SAID MJ DIVERSIFIED TRACT, AND A NORTHWEST CORNER OF SAID NEWELL TRACT;

THENCE WITH THE ARC OF A CURVE TO THE LEFT, HAVING A RADIUS OF 60.00 FEET, A DELTA ANGLE OF 148°44'29" , AN ARC LENGTH OF 155.76 FEET, A CHORD OF WHICH BEARS NORTH 54°09'56" WEST, A DISTANCE OF 115.57 FEET, WITH AN EAST RIGHT-OF-WAY LINE OF SAID GREENBRIER ROAD, A NORTH RIGHT-OF-WAY



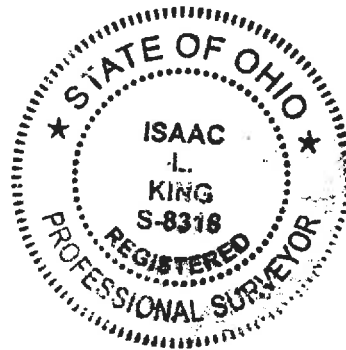
