**LEGAL DESCRIPTION OF A 2.300 ACRE PARCEL
FOR WEININGER HERITAGE FARM, LLC**

Being a parcel of land situated in part of the Southeast Quarter of Section 3, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the south quarter post of said Section 3;

thence on an assumed bearing of S 89° 53' 34" E along the south line of said Section 3 a distance of 1051.45 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 03° 14' 33" W on a line a distance of 436.00 feet to a set iron rod, passing a set iron rod a distance of 20.03 feet;

thence S 86° 51' 20" W on a line a distance of 135.00 feet to a set iron rod;

thence N 01° 07' 36" W on a line a distance of 412.59 feet to a set iron rod;

thence N 86° 05' 55" E on a line a distance of 200.00 feet to a set iron rod;

thence S 03° 54' 05" E on a line a distance of 229.10 feet to a set iron rod;

thence S 86° 05' 55" W on a line a distance of 40.00 feet to a found iron pipe;

thence S 03° 54' 05" E on a line a distance of 624.26 feet to a point marking the south line of said Section 3 and the centerline of Township Highway 11, passing a set iron rod a distance of 604.21 feet;

thence N 89° 53' 34" W along the south line of said Section 3 and the centerline of said Township Highway 11 a distance of 50.12 feet to the **POINT OF BEGINNING**.

Containing in all 2.300 acres of land, more or less, of which 0.023 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
