thence S 00° 13' 32" W, a distance of 501.00 feet to a set iron rod, passing a set iron rod a distance of 25.00 feet;

thence S 90° 00' 00" W, a distance of 269.35 feet to a set iron rod, passing a set iron rod a distance of 103.20 feet;

thence N 00° 13' 32" E, a distance of 501.00 feet to a set P-K nail on the centerline of State Route 182, passing a set iron rod a distance of 476.00 feet;

thence N 90° 00' 00" E along said centerline, a distance of 269.35 feet to the POINT OF BEGINNING.
