**LEGAL DESCRIPTION OF A 14.179 ACRE PARCEL
FOR PAUL STANSBERRY**

Being a parcel of land situated in part of the Northwest Quarter of Section 19, and part of the Southwest Quarter of Section 18, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found P-K nail marking the intersection of the North Line of Section 19 and the centerline of Township Highway 107 and being the POINT OF BEGINNING, referenced by a set iron rod located S 89° 26' 11" W a distance of 30.87 feet;

thence S 13° 04' 45" W along said centerline a distance of 249.99 feet to a found P-K nail, referenced by a set iron rod located N 79° 27' 49" W a distance of 30.00 feet;;

thence S 10° 32' 11" W along said centerline a distance of 411.80 feet to found P-K nail, referenced by a set iron rod located S 89° 55' 04" E a distance of 30.51 feet;;

thence S 12° 42' 08" W along said centerline a distance of 202.88 feet to a set iron rod;

thence S 22° 01' 16" W along said centerline a distance of 59.07 feet to a set iron rod;

thence S 31° 24' 49" W along said centerline a distance of 82.39 feet to a set iron rod, passing a set iron rod a distance of 55.29;

thence S 37° 48' 00" W along said centerline a distance of 246.58 feet to a set iron rod;

thence S 27° 20' 14" W along said centerline a distance of 305.34 feet to a set iron rod, passing a set iron rod a distance of 139.71 feet;

thence S 20° 07' 42" W along said centerline a distance of 133.97 feet to a set iron rod;

thence N 00° 02' 00" W a distance of 1678.95 feet to a set iron rod, passing a set iron rod on the North Line of Section 19 a distance of 1557.51 feet;

thence N 89° 28' 23" E a distance of 607.27 feet to a found iron rod on the centerline of Township Highway 107;

thence S 12° 39' 12" W along said centerline a distance of 124.34 feet to the POINT OF BEGINNING.

Containing in all 14.179 acres of land, more or less, subject to all legal highways and easements of record.

Being a parcel of land situated in part of the Northwest Quarter of Section 19, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a set P-K nail marking the southeast corner of the Northwest Quarter of said Section and being the POINT OF BEGINNING;

thence N 89° 47' 53" W along the centerline of State Route 103 a distance of 996.27 feet to a set P-K nail;

thence N 00° 02' 00" W a distance of 127.00 feet to a set iron rod passing a set iron rod a distance of 30.00 feet;

thence N 89° 47' 53" W a distance of 340.00 feet to a set P-K nail on the centerline of Township Highway 107, passing a set iron rod a distance of 310.00 feet;

thence N 00° 02' 00" W along said centerline a distance of 951.25 feet to a set iron rod;

thence N 20° 07' 42" E along said centerline a distance of 133.97 feet to a set iron rod;

thence N 27° 20' 14" E along said centerline a distance of 165.63 feet to a set iron rod;

thence S 89° 55' 04" E a distance of 1224.50 feet to a set iron rod on the east line of the northwest quarter of said section;

thence S 00° 24' 49" W along said line a distance of 1354.17 feet to the POINT OF BEGINNING, passing a set iron rod a distance of 1324.17 feet.
