Commencing at a set P-K nail marking the intersection of the centerline of Township Highway 46 and the east line of said Quarter Section and being the POINT OF BEGINNING, referenced by a found stone in a monument box situated S 71° 58' 35" E, a distance of 0.36 feet;

thence S 00° 04' 22" W along the east line of said Quarter Section a distance of 1810.79 feet to a point in the center of Potato Run, passing a set iron rod a distance of 1766.93 feet;

thence N 46° 14' 06" W along the centerline of Potato Run a distance of 696.00 feet to a point referenced by a set iron rod situated N 00° 17' 06" E a distance of 36.45 feet;

thence N 00° 17' 06" E a distance of 1491.26 feet to a set P-K nail on the centerline of Township Highway 46, passing a set iron rod a distance of 1459.76 feet;

thence S 71° 58' 35" E along said centerline a distance of 523.20 to the POINT OF BEGINNING, passing a found stone in a monument box a distance of 522.84 feet.

Containing in all 18.990 acres of land, more or less, subject to all legal highways and easements of record.

thence S 00° 04' 22" W along the centerline of Township Highway 79 a distance of 564.73 feet to a set P-K nail on the centerline of Township Highway 46, referenced by a found stone in a monument box situated S 71° 58' 35" E a distance of 0.36 feet;

thence N 71° 58' 35" W along the centerline of Township Highway 46 a distance of 523.20 feet to a set P-K nail;

thence S 00° 17' 06" W a distance of 1491.26 feet to a point in the center of Potato Run, passing a set iron rod a distance of 1454.81 feet;

thence N 46° 14' 06" W along the centerline of Potato Run a distance of 1145.19 feet to a set P-K nail on the centerline of Township Highway 79, passing a set iron rod a distance of 1103.85 feet;

thence N 00° 17' 06" E along the centerline of Township Highway 79 a distance of 1094.74 feet to a set iron rod on the north line of said Quarter Section;
