**LEGAL DESCRIPTION OF A 15.869 ACRE  
PARCEL FOR LARRY & SHARON SHIREY**

Being a parcel of land situated in part of the Northeast Quarter of Section 15, T-3-S, R-14-E, Pitt Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the Northeast Corner of said Section;

thence on an assumed bearing of S 00° 14' 12" W along the East Line of said Section a distance of 1331.78 feet to a set iron rod and being the **POINT OF BEGINNING**;

thence continuing S 00° 14' 12" W along said line a distance of 643.68 feet to a set iron rod;

thence N 78° 54' 54" W a distance of 550.64 feet to a found iron pipe;

thence S 02° 53' 21" E a distance of 196.79 feet to a found iron pipe marking the northeast corner of Lot #6 of Dewitt Voorheis Land Subdivision;

thence N 68° 36' 39" W along the north line of said Lot #6 a distance of 204.57 feet to a found iron pipe marking the northwest corner of said Lot #6;

thence S 14° 34' 05" W along the west line of said Lot #6 a distance of 25.03 feet to a found iron pipe marking the northeast corner of Lot #5 of said Subdivision;

thence N 87° 50' 08" W along the north line of said Lot #5 a distance of 252.01 feet to a found iron pipe marking the northeast corner of Lot #4 of said Subdivision;

thence S 75° 36' 39" W along the north line of said Lot #4 a distance of 134.08 feet to a set iron rod marking the southeast corner of Lot #3 of said Subdivision;

thence N 00° 03' 29" W along the east line of said Lot #3 extended a distance of 341.82 feet to a set iron rod;

thence S 89° 55' 45" W a distance of 200.00 feet to a set MAG nail on the centerline of County Highway 60, passing a set iron rod a distance of 170.00 feet;

thence N 00° 03' 29" W along said centerline a distance of 75.00 feet to a set MAG nail;

thence N 89° 57' 16" E a distance of 300.08 feet to a found iron pipe, passing a found iron pipe a distance of 30.00 feet;

thence N 00° 04' 29" W a distance of 278.15 feet to a found iron pipe;

thence N 89° 16' 33" E a distance of 1012.39 feet to the **POINT OF BEGINNING**.

Containing in all 15.869 acres of land, more or less, of which 0.034 acres, more or less, is currently contained within the right-of-way of County Highway 60. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and for angular measurement only.

All set iron rods are 5/8" diameter with plastic caps imprinted "VBK #7457".
