Being a parcel of land situated in part of the Northwest Quarter of Section 34 and the Northeast Quarter of Section 33, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a set MAG nail marking the intersection of the north line of said Section and the centerline of Township Highway 40, referenced by a set iron rod situated S 89° 56' 59" W a distance of 21.87 feet;

thence on an assumed bearing of S 23° 49' 40" W along the centerline of Township Highway 40 a distance of 658.96 feet to a set MAG nail and being the **POINT OF BEGINNING**, passing a set MAG nail a distance of 372.00 feet;

thence continuing S 23° 49' 40" W along said centerline a distance of 353.12 feet to a set iron rod;

thence S 00° 50' 16" E along said centerline a distance of 50.46 feet to a set MAG nail;

thence S 87° 03' 15" W a distance of 397.98 feet to a set iron rod, passing a set iron rod a distance of 20.01 feet;

thence N 02° 53' 28" W a distance of 896.46 feet to a set iron rod;

thence N 86° 33' 47" E a distance of 169.85 feet to a set iron rod;

thence S 02° 53' 28" E a distance of 543.14 feet to a set iron rod;

thence N 85° 26' 44" E a distance of 388.88 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 366.15 feet.

Containing in all 5.953 acres of land, more or less, of which 0.185 acre, more or less, is currently contained within the right-of-way of Township Highway 40. The above described property being subject to all legal highways and easements of record.

Commencing at a set MAG nail marking the intersection of the north line of said Section and the centerline of Township Highway 40 and being the **POINT OF BEGINNING**, referenced by a set iron rod situated S 89° 56' 59" W a distance of 21.87 feet;

thence on an assumed bearing of S 23° 49' 40" W along the centerline of Township Highway 40 a distance of 372.00 feet to a set MAG nail;

thence S 89° 56' 59" W a distance of 219.14 feet to a set iron rod, passing a set iron rod a distance of 21.87 feet;

thence N 00° 50' 16" W a distance of 340.19 feet to a set iron rod on the north line of said Section;

thence N 89° 56' 59" E along the north line of said Section a distance of 374.40 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 352.53 feet.
