**LEGAL DESCRIPTION FOR A 2.0037 ACRE PARCEL
FOR MELVIN COLE
PARCEL ONE (1)**

Being a parcel of land situated in part of the northwest quarter *of the Northeast* (1/4) of Section Four (4), Town-Three (3), Range-Fifteen (15) East, Antrim Township, Wyandot County, Ohio described as follows:

- 1.) Commencing at a found monument box marking the southeast corner of Section Thirty-Three (33), Town-Two (2), Range-Fifteen (15) East, Eden Twp., Wyandot Co., said point being on the centerline intersection of Morrison Street and West Center Street;
- 2.) thence N 89° 26' 42" W one thousand seven hundred thirty-five and twenty-four hundredths (1735.24) feet along the centerline of West Center Street to a found pipe (1.37' S);
- 3.) thence S 02° 01' 17" W twenty (20.00) feet to the south right-of-way of West Center Street marking the POINT OF BEGINNING, referenced by a found iron pipe bearing N 02° 01' 17" E eighteen and sixty-three hundredths (18.63) feet;
- 4.) thence S 89° 26' 42" E two hundred eighty-seven and twenty hundredths (287.20) feet along the south right-of-way of West Center Street to a set iron rod;
- 5.) thence S 04° 33' 18" W one hundred eighty-seven and seventy-six hundredths (187.76) feet along the west line of a sixteen (16) foot alley to a point, referenced by a set iron rod bearing S 85° 18' 22" E twenty-seven and seventy-eight hundredths (27.78) feet;
- 6.) thence S 85° 18' 22" E twenty-seven and seventy-eight hundredths (27.78) feet along the south line of a sixteen (16) foot alley to a set iron rod;
- 7.) thence S 04° 00' 00" W one hundred twenty-two and fifty hundredths (122.50) feet along the west line of a parcel of land now or formerly owned by Carl Shope, etux (Vol. 183, Pg. 443) to a set iron rod;

- 8.) thence N 84° 58' 46" W three hundred two and seventy-four hundredths (302.74) feet along the north line of a parcel of land now or formerly owned by Consolidated Rail Corp. to a set iron rod;
- 9.) thence N 02° 01' 17" E two hundred eighty-eight and twelve hundredths (288.12) feet along the east line of a parcel of land now or formerly owned by Richard Healey, etux. (Vol. 176, Pg. 247) to the POINT OF BEGINNING.
