## PARCEL #2 LEGAL DESCRIPTION

Being a parcel of land situated in the Northeast Quarter of Section 3, Sycamore Township, Township-1-South, Range-15-East, Wyandot County, Ohio, described as follows:

**BEGINNING** at a found iron rod marking the Northeast Corner of Section 3 and the centerline intersection of County Road 1 and Township Road 10 referenced by a set iron rod at S 47° 32' 10" W forty-five and eighteen hundredths (45.18) feet;

thence S 00° 37' 19" W six hundred sixty and twenty-eight hundredths (660.28) feet along the easterly line of said section and the centerline of Township Highway 10 to a set nail marking the Northeasterly corner of a 60 acre parcel of land now or formerly owned by Glen Wickham as described in Wyandot County Deed Volume 204, Page 709, 711 referenced by a set iron rod at S 89° 50' 02" W thirty-three and zero hundredths (33.00) feet;

thence S 89° 50' 02" W two hundred sixty-three and eight hundredths (263.08) feet along Wickham's northerly line to the centerline of a ditch, referenced by a set iron rod at S 89° 50' 02" W thirty-five (35) feet;

thence along the centerline of ditch as follows:

thence N 07° 38' 28" E ninety-six and twenty-five hundredths (96.25) feet from which a set iron rod for reference bears S 90° 00' 00" W forty-five (45) feet;

thence N 09° 06' 24" W one hundred thirty-three and fifty-one hundredths (133.51) feet from which a set iron rod for reference bears S 90° 00' 00" W twenty (20) feet;

thence N 03° 55' 34" W one hundred twenty-two and twenty-nine hundredths (122.29) feet from which a set iron rod for reference bears S 90° 00' 00" W fifteen (15) feet;

thence N 04° 08' 36" W ninety-eight and eighty-three hundredths (98.83) feet from which a set iron rod for reference bears S 90° 00' 00" W thirty-five (35) feet;

thence N 32° 45' 10" W eighty-one and fourteen hundredths (81.14) feet from which a set iron rod for reference bears S 90° 00' 00" W twenty (20) feet;

thence N 59° 39' 04" W one hundred twenty-eight and forty-nine hundredths (128.49) feet from which a set iron rod for reference bears S 00° 00' 00" W thirty-five (35) feet;

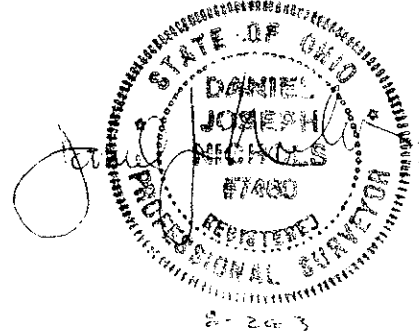

thence S 00° 00' 00" W ninety-one and sixty-six hundredths (91.66) feet to the centerline of a ditch referenced by a set iron rod at S 00° 00' 00" W fifteen (15) feet;

thence along the centerline of ditch as follows:
