Commencing at a found stone in a monument box marking the Northeast Corner of said Section 10;

thence on an assumed bearing of N 90° 00' 00" W along the centerline of County Highway 56 a distance of 719.45 feet to a found MAG nail referenced by the next mentioned found iron rod and marking the northeasterly corner of a parcel of land currently owned by The Board of Commissioners for Wyandot County, passing a set MAG nail a distance of 270.00 feet;

thence S 00° 05' 21" E along an easterly line of said Wyandot County parcel a distance of 32.78 feet to a found iron rod;

thence S 78° 35' 20" W along a southerly line of said Wyandot County parcel a distance of 83.65 feet to a found iron rod;

thence S 87° 00' 00" W along a southerly line of said Wyandot County parcel a distance of 99.85 feet to a set iron rod and being the **POINT OF BEGINNING**

thence S 00° 49' 14" W a distance of 435.00 feet to a set iron rod;

thence N 90° 00' 00" W a distance of 410.77 feet to a set iron rod on the east line of a parcel of land currently owned by the Ruth E. McClain Trust, et al;

thence N 00° 49' 14" E along the east line of said McClain Trust parcel a distance of 413.45 feet to a found iron rod marking the southwesterly corner of the aforementioned Wyandot County parcel;

thence N 87° 00' 00" E along a southerly line of said Wyandot County parcel a distance of 411.64 feet to the **POINT OF BEGINNING**.

Containing in all 4.000 acres of land, more or less, being subject to all legal highways and easements of record.

thence on an assumed bearing of S 00° 48' 33" W along the east line of said Section 10 a distance of 645.40 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 90° 00' 00" W a distance of 270.00 feet to a set iron rod;

thence N 00° 48' 33" E a distance of 645.40 feet to a set MAG nail on the centerline of County Highway 56, passing a set iron rod a distance of 625.40 feet;

thence S 90° 00' 00" E along said centerline a distance of 270.00 feet to the **POINT OF BEGINNING**.
