Commencing at a set railroad spike marking the Northwest Corner of said Section 4 referenced by a set iron rod situated S 56° 13' 34" E a distance of 36.06 feet;

thence on an assumed bearing of S 89° 54' 51" E along the centerline of County Highway 4 a distance of 339.50 feet to a set MAG nail and being the **POINT OF BEGINNING**, referenced by a set iron rod situated S 00° 04' 44" W a distance of 20.00 feet;

thence continuing S 89° 54' 51" E along said centerline a distance of 862.54 feet to a set MAG nail marking the northwest corner of a parcel of land currently owned by D. C. Gottfried, L. E., et al, Trust,

thence S 00° 04' 44" W along the west line of said Gottfried Trust parcel a distance of 1458.93 feet to a set iron rod on the north line of a parcel of land currently owned by L. Smalley marking the southwest corner of said Gottfried Trust parcel, passing a set iron rod for reference a distance of 20.00 feet;

thence N 89° 44' 55" W along the north line of said Smalley parcel a distance of 1202.05 feet to a found railroad spike on the centerline of County Highway 97 marking the northwest corner of said Smalley parcel, passing a set iron rod for reference a distance of 1172.05 feet;

thence N 00° 04' 44" E along said centerline a distance of 1224.34 feet to a set MAG nail;

thence S 89° 54' 51" E a distance of 339.50 feet to a set iron rod, passing a set iron rod for reference a distance of 30.00 feet;

thence N 00° 04' 44" E a distance of 231.12 feet to the **POINT OF BEGINNING**, passing a set iron rod for reference a distance of 211.12 feet.

thence on an assumed bearing of S 89° 54' 51" E along the centerline of County Highway 4 a distance of 339.50 feet to a set MAG nail;

thence S 00° 04' 44" W a distance of 231.12 feet to a set iron rod, passing a set iron rod for reference a distance of 20.00 feet;

thence N 89° 54' 51" W a distance of 339.50 feet to a set MAG nail on the centerline of County Highway 97, passing a set iron rod for reference a distance of 309.50 feet;

thence N 00° 04' 44" E along said centerline a distance of 231.12 feet to the **POINT OF BEGINNING**.
