and the west line of the east half of the southeast quarter of said Section 13 referenced by
a set iron rod situated S 45° 00' 00" E a distance of 23.56 feet;

thence on an assumed bearing of S 89° 27' 17" E along said centerline a distance of
514.23 feet to a found iron rod and being the **POINT OF BEGINNING**;

thence continuing S 89° 27' 17" E along said centerline a distance of 151.46 feet to a
point, referenced by a found iron pipe situated S 86° 07' 08" E a distance of 78.57 feet;

thence along said centerline an arc distance of 53.58 feet along a curve to the left having


