thence S 89° 43' 19" E along a south line of said Heilman parcel a distance of 949.84 feet to a set iron rod marking a corner of said Heilman parcel;

thence N 11° 36' 37" W along a line of said Heilman parcel a distance of 148.50 feet to a set iron rod marking a corner of said Heilman parcel;

thence S 89° 43' 19" E along a line of said Heilman parcel a distance of 206.81 feet to a set iron rod marking a corner of said Heilman parcel;

Highway 57 a distance of 1651.82 feet to a set MAG nail marking the southwest corner
of a parcel of land currently owned by D. Weaver, et ux;

thence N 89° 53' 51" E along the south line of said Weaver parcel a distance of 653.00
feet to a set iron rod on the west line of the east half of the west half of the southwest
quarter marking the southeast corner of said Weaver parcel, passing a set iron rod for
reference a distance of 30.00 feet;
