Being a parcel of land situated in the Southeast Quarter of Section 7 and the Southwest Quarter of Section 8, T-2-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found MAG nail marking the centerline of State Highway 53 and the south line of said Section 8, referenced by a found iron pipe situated N 51° 04' 47" W a distance of 34.73 feet;

thence on an assumed bearing of N 04° 53' 34" E along the centerline of said State Highway 53 a distance of 1332.00 feet to a set MAG nail marking the north line of the south half of the southwest quarter of said Section 8 and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 89° 15' 57" W a distance of 25.07 feet;

thence N 89° 15' 57" W along the north line of the south half of the southwest quarter of said Section 8 a distance of 2089.26 feet to a set iron rod marking the west line of said Section 8 and the southeast corner of a parcel of land now or formerly owned by D. Gibson;

thence N 00° 30' 25" E along the west line of said Section 8 and the east line of said D. Gibson parcel a distance of 137.01 feet to a set iron rod marking the northeast corner of said D. Gibson parcel;

thence S 89° 58' 42" W along the north line of said D. Gibson parcel a distance of 1324.41 feet to a set MAG nail marking the centerline of County Highway 112, passing a set iron rod for reference a distance of 1304.41 feet;

thence N 00° 33' 41" E along the centerline of said County Highway 112 a distance of 462.40 feet to a set MAG nail, referenced by a set iron rod situated S 89° 15' 57" E a distance of 20.00 feet;

thence S 89° 15' 57" E on a line a distance of 3457.80 feet to a set MAG nail marking the centerline of said State Highway 53, passing aforementioned set iron rod a distance of 20.00 feet, also passing a set iron for reference a distance of 3432.73 feet;

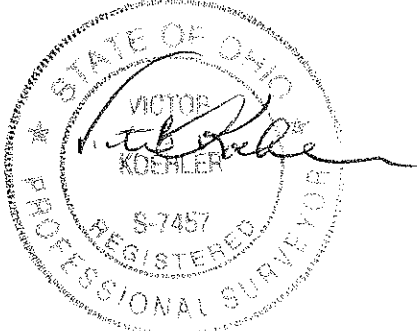

Commencing at a found MAG nail marking the centerline of State Highway 53 and the south line of said Section 8, referenced by a found iron pipe situated N 51° 04' 47" W a distance of 34.73 feet, said nail being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 89° 18' 58" W along the south line of said Section 8 and the centerline of County Highway 44 a distance of 922.39 feet to a found MAG nail marking the southeast corner of a parcel of land now or formerly owned by D. & J. Niederkohr, said nail referenced by a found iron pipe situated N 00° 30' 22" E a distance of 22.02 feet;

thence N 00° 30' 22" E along the east line of said D. & J. Niederkohr parcel a distance of 1329.31 feet to a set iron rod marking the north line of the south half of the southwest quarter of said Section 8;

thence S 89° 15' 57" E along the north line of the south half of the southwest quarter of said Section 8 a distance of 1024.27 feet to a set MAG nail marking the centerline of said State Highway 53, passing a set iron rod for reference a distance of 999.20 feet;

thence S 04° 53' 34" W along the centerline of said State Highway 53 a distance of 1332.00 feet to the **POINT OF BEGINNING**.

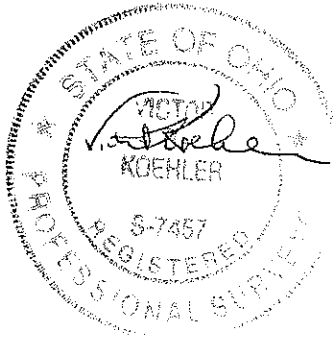
