Being a parcel of land situated in part of the Northeast and Southeast Quarters of Section 1, T-1-S, R-12-E, Ridge Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the center of said Section 1 and the centerline of Township Highway 95 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 00° 36' 41" E along the north-south half section line of said Section 1 and the centerline of Township Highway 95 a distance of 643.89 feet to a set MAG nail, referenced by a set iron rod situated S 89° 18' 22" E a distance of 20.00 feet;

thence S 89° 18' 22" E on a line a distance of 2639.74 feet to a set iron rod marking the east line of said Section 1 and the west line of a parcel of land now or formerly owned by C. Lamberjack, Etux., passing the aforementioned set iron rod a distance of 20.00 feet;

thence S 00° 37' 05" W along the east line of said Section 1 and the west line of said Lamberjack parcel and the west line of parcels of land now or formerly owned by D. Shuman, Etux and D. Walter, respectively, a distance of 1971.37 feet to a set iron rod marking a corner of a parcel of land now or formerly owned by E. Walter;

thence N 89° 15' 45" W along the north line of said E. Walter parcel and a parcel of land now or formerly owned by Ridge Township Trustees a distance of 2638.95 feet to a set MAG nail marking the north-south half section line of said Section 1 and the centerline of Township Highway 95, passing a set iron rod a distance of 2618.95 feet;

thence N 00° 35' 13" E along the north-south half section line of said Section 1 and the centerline of Township Highway 95 a distance of 1325.48 feet to the **POINT OF BEGINNING**.

Containing in all 119.390 acres of land, more or less, of which 0.904 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

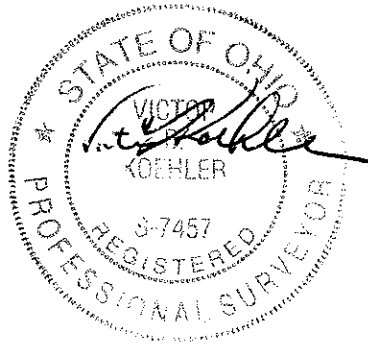

Commencing at a found stone marking the northeast corner of said Section 1, the centerline of County Highway 3 and the west line of a parcel of land now or formerly owned by C. Lamberjack, Etux. and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 00° 37' 05" W along the east line of said Section 1 and the west line of said Lamberjack parcel a distance of 1977.88 feet to a set iron rod;

thence N 89° 18' 22" W on a line a distance of 2639.74 feet to a set MAG nail marking the north-south half section line of said Section 1 and the centerline of Township Highway 95, passing a set iron rod a distance of 2619.74 feet;

thence N 00° 36' 41" E along the north-south half section line of said Section 1 and the centerline of Township Highway 95 a distance of 1982.93 feet to a point on the north line of said Section 1 and the centerline of County Highway 3, passing a found monument box a distance of 1981.01 feet;

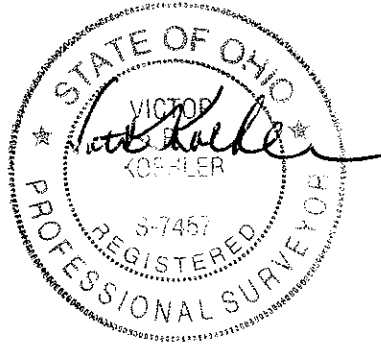
