**LEGAL DESCRIPTION**  
**Tong Farms**

4.000 Acres

Situated in the Township of Ridge, County of Wyandot, State of Ohio, and being a part of W1/2 of the SW1/4 of Section 11, T1S, R12E, a tract of land bounded and described as follows:

Commencing at a nail found marking the intersection of the centerline of Township Highway 22 with the west line of the NW1/4 of said Section 11 (referenced by an iron pin found S00°16'12"W a distance of 30.01 feet);

thence along the west line of said Section 11, also being the Wyandot County-Hancock County Line S00°16'12"W a distance of 3067.42 feet to an iron pin set marking the northwest corner of a 60.50 acre tract of land conveyed to Daniel R. Tong, etal in OR Book 248, Page 1885 and OR Book 250, Page 2447 of the Wyandot County Official Records;

thence along the north line of said 60.50 acre tract N89°49'31"E a distance of 657.80 feet to an iron pin set marking the southeast corner of a 55.00 acre tract of land conveyed to Daniel R. Tong, etal in OR Book 248, Page 1885 and OR Book 250 Page 2447 of the Wyandot County Official Records and being the Principal Point of Beginning of the tract of land to be herein described;

thence from the above described Principal Point of Beginning and along the north line of said 60.50 acre tract N89°49'31"E a distance of 657.80 feet to an iron pin set on the east line of the W1/2 of the SW1/4 of said Section 11, and being a northeast corner of said 60.50 acre tract;

thence along said east line S00°19'30"W a distance of 264.92 feet to an iron pin set;  
thence parallel with the north line of said 60.50 acre tract S89°49'31"W a distance of 657.68 feet to an iron pin set;

thence N00°17'51"E a distance of 264.92 feet to the Principal Point of Beginning, and containing 4.000 acres of land, more or less, subject however to all prior easements of record.
