0.219 Acres

Situated in the Township of Ridge, County of Wyandot, State of Ohio and being a part of the SE1/4 of Section 2, and a part of the NE1/4 of Section 11, T1S, R12E, a tract of land bounded and described as follows:

Beginning at a stone found marking the southeast corner of the SE1/4 of said Section 2, referenced by a 5/8" iron pin found S74°22'38"E a distance of 0.56 feet;

thence along the south line of a 26.327 acre tract of land as described in OR 254, Page 1745, of the Wyandot County Official Records N86°51'56"W a distance of 217.79 feet to a 5/8" iron pin found with HANK cap on the northeasterly right of way line of State Route 568;

thence along the northeasterly right of way line of said State Route 568 (60' R/W) N44°06'35"W a distance of 58.92 feet to an iron pin set;

thence parallel with and 40.00 feet right angle dimension north of the south line of said 26.327 acre tract S86°51'56"E a distance of 258.51 feet to an iron pin set on the east line of the SE1/4 of said Section 2, and being the west line of a 89.784 acre tract of land as described in OR 254, Page 1745 of the Wyandot County Official Records;

thence along the east line of the SE1/4 of said Section 2, also being the west line of said 89.784 acre tract S00°30'22"E" a distance of 40.08 feet to the point of beginning, and containing 0.219 acre of land, more or less, of which 0.086 acre lies in the NE1/4 of Section 11, and 0.133 acre lies in the SE1/4 of Section 2, subject however to all prior easements of record;

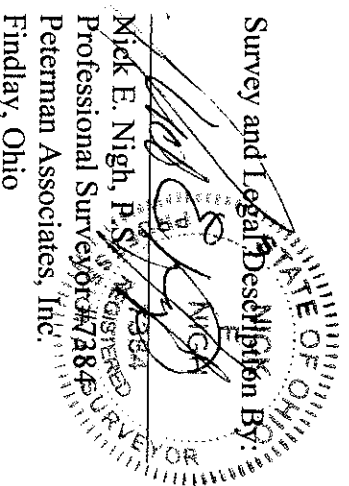
