**LEGAL DESCRIPTION OF A 25.042 ACRE PARCEL
FOR DON & JUDY MAY**

Being a parcel of land situated in part of the Northwest Quarter of Section 20, T-1-S,
R-15-E, Sycamore Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the west quarter post of said Section 20;

thence on an assumed bearing of N 87° 43' 05" E along the east-west half section line of
said Section 20 a distance of 882.42 feet to a set iron rod marking a corner of a parcel of
land now or formerly owned by M. Danner and the Village of Sycamore Corporation line
and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 02° 26' 32" W along said M. Danner parcel and parcels of land now or formerly
owned by K. Williams, Village of Sycamore and American Legion Post #250 a distance
of 1001.62 feet to a set iron rod marking the south right-of-way line of Tenth Street;

thence N 87° 45' 01" E along said south right-of-way line of Tenth Street a distance of
16.50 feet to a set iron rod marking the east right-of-way of Pemberton Street;

thence N 02° 21' 23" W along the east right-of-way line of said Pemberton Street a
distance of 104.28 feet to a found iron pipe marking the southwest corner of a parcel of
land now or formerly owned by T. Esterline, Etux.;

thence N 87° 49' 04" E along said T. Esterline, Etux. parcel a distance of 439.64 feet to a
set iron rod marking the west line of the east half of the northwest quarter of said Section
20 and being the west line of a parcel of land now or formerly owned by D. Lee, passing
a found iron pipe a distance of 207.80 feet;

thence S 02° 17' 25" E along said line a distance of 293.70 feet to a found iron rod
marking a corner of said D. Lee parcel;

thence N 87° 42' 08" E along said D. Lee parcel a distance of 107.25 feet to a found iron
rod marking a corner of said D. Lee parcel;

thence N 02° 17' 25" W along said D. Lee parcel a distance of 614.55 feet to a found iron rod marking a corner of said D. Lee parcel and a parcel of land now or formerly owned by B. Ekleberry;

thence S 54° 24' 28" E along said B. Ekleberry parcel a distance of 499.79 feet to a found iron rod marking a corner of a parcel of land now or formerly owned by T. Robinson, Trustee;

thence S 02° 21' 16" E along said T. Robinson, Trustee parcel a distance of 1119.17 feet to a set iron rod marking the east-west half section line of said Section 20;

thence S 87° 43' 05" W along said east-west half section line of said Section 20 a distance of 956.34 feet to the **POINT OF BEGINNING**.

Containing in all 25.042 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.


