**LEGAL DESCRIPTION OF A 49.773 ACRE PARCEL  
FOR RELCO LLC**

Being a parcel of land situated in part of the Northeast and Northwest Quarters of Section 31, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the north quarter post of said Section 31 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 89° 55' 10" E along the north line of said Section 31 a distance of 473.55 feet to a found iron rod marking the northwest corner of a parcel of land now or formerly owned by RELCO LLC;

thence S 00° 22' 00" W along the west line of said RELCO LLC parcel a distance of 1695.18 feet to a found MAG nail marking the centerline of County Highway 38 and the former Wyandot Indian Reservation Line, passing a found iron rod a distance of 1675.18 feet;

thence S 89° 54' 33" W along the centerline of said County Highway 38 and the former Wyandot Indian Reservation Line a distance of 469.07 feet to a found stone marking the north-south half section line of said Section 31;

thence S 89° 49' 20" W along the centerline of said County Highway 38 and the former Wyandot Indian Reservation Line a distance of 5.48 feet to a found railroad spike marking a corner of a parcel of land now or formerly owned by D. Mewhorter, Etal. referenced by a found iron rod situated N 00° 12' 37" W a distance of 20.00 feet;

thence N 00° 12' 37" W along said D. Mewhorter, Etal. parcel a distance of 356.20 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel, passing the aforementioned found iron rod a distance of 20.00 feet;

thence N 89° 49' 20" E along said D. Mewhorter, Etal. parcel a distance of 109.08 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel;

thence N 00° 10' 40" W along said D. Mewhorter, Etal. parcel a distance of 297.81 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel;

thence S 89° 49' 20" W along said D. Mewhorter, Etal. parcel a distance of 295.83 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel;

thence S 00° 10' 40" E along said D. Mewhorter, Etal. parcel a distance of 297.81 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel;

thence N 89° 49' 20" E along said D. Mewhorter, Etal. parcel a distance of 161.75 feet to a found iron rod marking a corner of said D. Mewhorter, Etal. parcel;

thence S 00° 12' 37" E along said D. Mewhorter, Etal. parcel a distance of 356.20 feet to a found MAG nail marking the centerline of said County Highway 38 and the former Wyandot Indian Reservation Line, passing a found iron rod a distance of 336.20 feet;

thence S 89° 49' 20" W along the centerline of said County Highway 38 and the former Wyandot Indian Reservation Line a distance of 834.52 feet to a set MAG nail, referenced by a set iron rod situated N 00° 19' 30" E a distance of 20.00 feet;

thence N 00° 19' 30" E on a line a distance of 1701.26 feet to a set iron rod marking the north line of said Section 31;

thence S 89° 46' 44" E along the north line of said Section 31 a distance of 861.72 feet to the **POINT OF BEGINNING**, passing a found iron rod a distance of 180.47 feet.

Containing in all 49.773 acres of land, more or less, of which 0.601 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
