Commencing at a found railroad spike marking the southeast corner of said Section 5 and the centerline of Township Highway 42 and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 00° 08' 48" E a distance of 30.00 feet;

thence on an assumed bearing of N 89° 41' 03" W along the south line of said Section 5 and the centerline of said Township Highway 42 a distance of 149.20 feet to a found MAG nail marking a corner of a parcel of land now or formerly owned by D. Beck, referenced by a found iron rod situated N 00° 18' 57" E a distance of 30.00 feet;

thence N 00° 18' 57" E along said D. Beck parcel a distance of 225.30 feet to a found iron rod marking a corner of said D. Beck parcel, passing the aforementioned found iron rod a distance of 30.00 feet;

thence N 89° 41' 03" W along the north line of said D. Beck parcel a distance of 239.23 feet to a found iron rod marking a corner of said D. Beck parcel;

thence S 00° 18' 57" W along said D. Beck parcel a distance of 225.30 feet to a found railroad spike marking the south line of said Section 5 and the centerline of said Township Highway 42, passing a set iron rod a distance of 195.30 feet;

thence N 00° 12' 02" E on a line a distance of 1318.45 feet to a set iron rod marking south line of the north half of the southeast quarter of said Section 5, passing the aforementioned set iron rod a distance of 30.00 feet;

Commencing at a found stone marking the south eighth post of the southeast quarter of said Section 5 and the intersection of the centerlines of Township Highway 80 and Township Highway 42 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 00° 12' 02" E along the west line of the east half of the southeast quarter of said Section 5 and the centerline of said Township Highway 80 a distance of 1315.92 feet to a set MAG nail marking the south line of the north half of the southeast quarter of said Section 5, referenced by a set iron rod situated S 89° 54' 09" E a distance of 30.00 feet;

thence S 89° 54' 09" E along the south line of the north half of the southeast quarter of said Section 5 a distance of 664.34 feet to a set iron rod, passing the aforementioned set iron rod a distance of 30.00 feet;

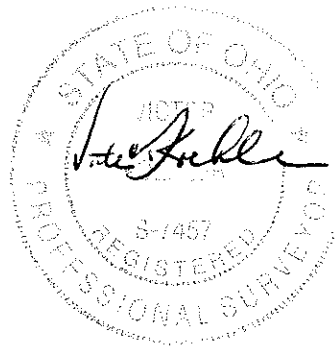
