**LEGAL DESCRIPTION OF A 20.101 ACRE PARCEL  
FOR DAVID NAUS**

Being a parcel of land situated in part of the Southwest and Southeast Quarters of Section 5, T-4-S, R-15-E, Antrim Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the south quarter post of said Section 5 and the centerline of County Highway 74;

thence on an assumed bearing of S 89° 51' 49" W along the south line of said Section 5 and the centerline of said County Highway 74 a distance of 347.10 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 01° 25' 14" E a distance of 20.01 feet;

thence continuing S 89° 51' 49" W along the south line of said Section 5 and the centerline of said County Highway 74 a distance of 40.01 feet to a set MAG nail marking a corner of a parcel of land now or formerly owned by W. K. & V. Brown;

thence N 01° 25' 14" E along said W. K. & V. Brown parcel and parcels of land now or formerly owned by A. & M. Depinet and Maken-Bacon Farms a distance of 2649.14 feet to a found stone marking a corner of said Maken-Bacon Farms parcel, marking the east-west half section line of said Section 5 and the centerline of Township Highway 72, passing a set iron rod a distance of 20.01 feet;

thence S 89° 51' 43" E along said east-west half section line of said Section 5 and the centerline of said Township Highway 72 a distance of 29.97 feet to a found MAG nail marking a corner of a parcel of land now or formerly owned by T.A. Baker;

thence S 01° 30' 08" W along said T. A. Baker parcel a distance of 353.97 feet to found iron pipe, passing a found iron pipe a distance of 19.87 feet;

thence S 01° 25' 14" W on a line a distance of 425.62 feet to a set iron rod;

thence N 89° 50' 34" E on a line a distance of 261.52 feet to a set iron rod;

thence S 46° 12' 12" E on a line a distance of 416.99 feet to a set iron rod;

thence S 65° 01' 44" E on a line a distance of 261.36 feet to a set iron rod;  
thence S 81° 51' 09" E on a line a distance of 144.45 feet to a set iron rod;  
thence S 76° 10' 18" E on a line a distance of 163.58 feet to a set iron rod;  
thence S 45° 46' 28" E on a line a distance of 63.91 feet to a set iron rod;  
thence S 89° 44' 59" E on a line a distance of 72.00 feet to a set iron rod;  
thence S 01° 33' 49" W on a line a distance of 86.62 feet to a set iron rod;  
thence N 89° 44' 59" W on a line a distance of 286.17 feet to a set iron rod;  
thence S 04° 01' 06" W on a line a distance of 283.25 feet to a set iron rod;  
thence S 88° 20' 56" W on a line a distance of 472.77 feet to a set iron rod;  
thence S 01° 25' 14" W on a line a distance of 220.00 feet to a set iron rod;  
thence S 88° 20' 56" W on a line a distance of 450.00 feet to a set iron rod;  
thence S 01° 25' 14" W on a line a distance of 751.96 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 731.95 feet.

Containing in all 20.101 acres of land, more or less, of which 0.032 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
