thence on an assumed bearing of N 00° 37' 47" W along the west line of said Section 27 a distance of 2016.76 feet to a found iron rod on the southerly limited access right-of-way line of United States Route 23;

thence S 43° 49' 11" E along said limited access right-of-way line a distance of 114.79 feet to a found concrete monument situated 125.00 feet left of ODOT Station 543+00 of United States Route 23;

thence S 32° 17' 08" E along said limited access right-of-way line a distance of 712.05 feet to a set iron rod situated 55.00 feet right of ODOT Station 14+24.92 (Ramp "A") of United States Route 23, passing a found iron rod a distance of 611.29 feet;

thence S 23° 38' 49" E along said limited access right-of-way line a distance of 116.28 feet to a set iron rod and being the **POINT OF BEGINNING**;

thence continuing S 23° 38' 49" E along said limited access right-of-way line a distance of 125.00 feet to a set iron rod;

thence S 69° 21' 20" W a distance of 277.34 feet to a found iron rod on an easterly line of a parcel of land currently owned by Upper, LTD.;

thence N 23° 35' 30" W along an easterly line of said Upper, LLC. parcel a distance of 182.70 feet to a set iron rod;

thence N 80° 58' 40" E a distance of 286.05 feet to the **POINT OF BEGINNING**.
