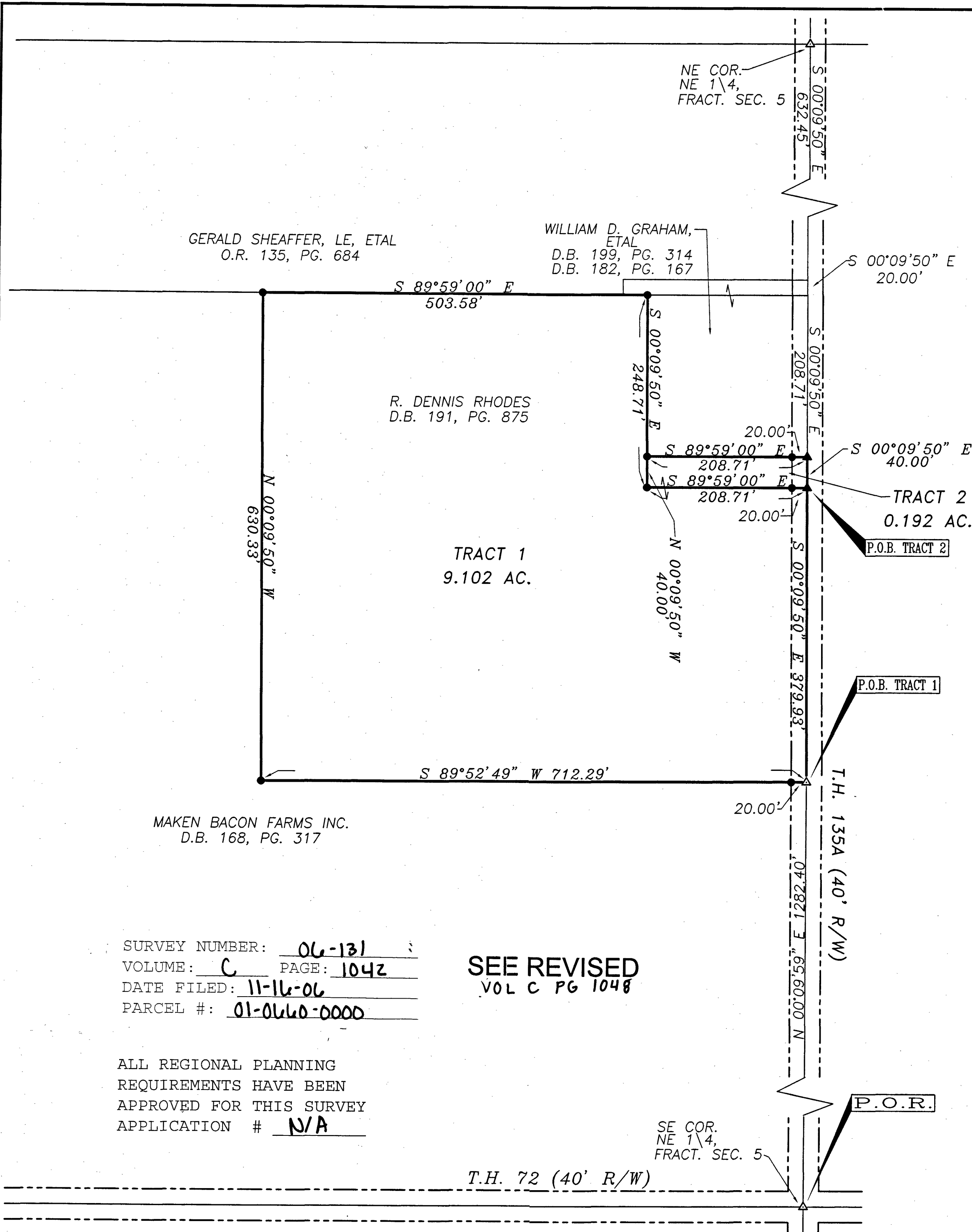




DESCRIPTION

NOTES

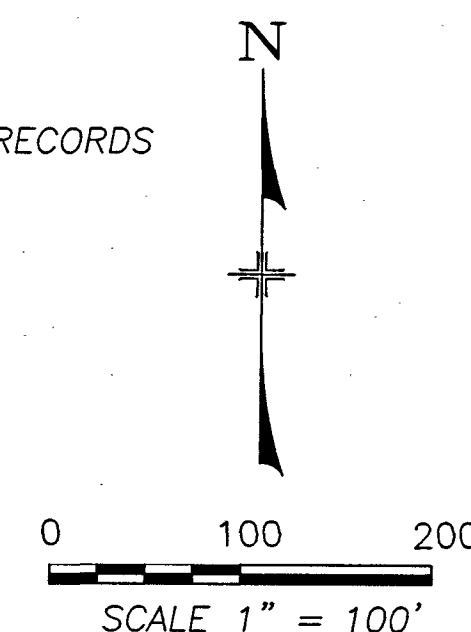

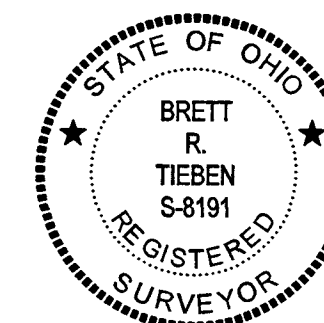
