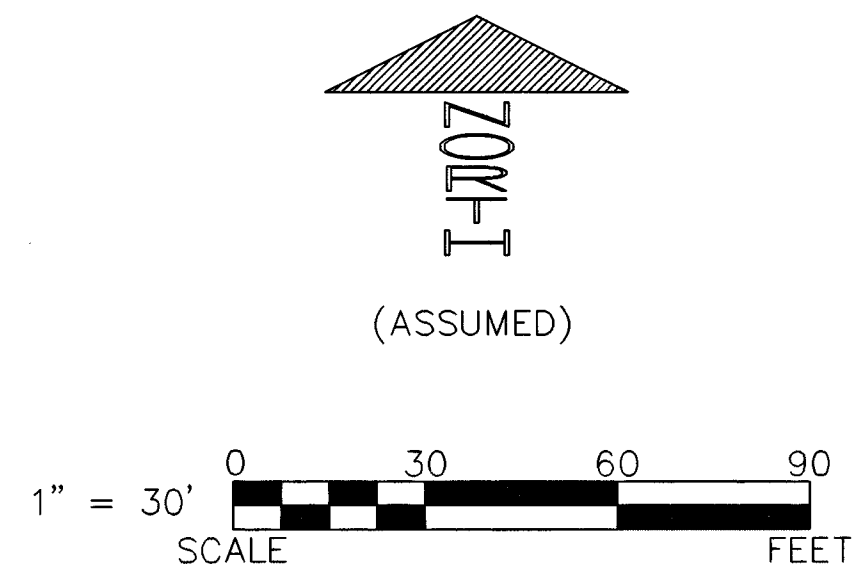


- 1). OVER THE YEARS THE WYANDOT COUNTY TAX MAPS HAVE SHOWN AN ALLEY (R/W - 16.5') AT THE LOCATION SHOWN HEREON. THE CURRENT LEGAL DESCRIPTION (FOR L. K. HENSEL, ET UX) INCLUDES THIS AREA (WHERE CROSS HATCHED) WITHIN IT'S BOUNDS. THE RECORDED PLATS ESTABLISHING THE INLOTS FRONTING MAIN STREET DO NOT ILLUSTRATE THE PRESENCE OF AN ALLEY. ONLY SLIDE NO. 41, REFERENCED HEREON, ILLUSTRATES THE PRESENCE OF AN ALLEY. THIS SLIDE APPEARS TO BE AN OVERVIEW OF THE ENTIRE TOWN AND NOT MADE FOR SPECIFIC LOT AND ROADWAY PLATTING/CONFIGURATIONS.

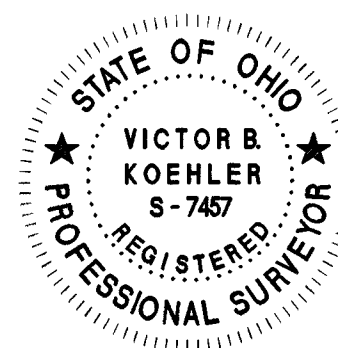
