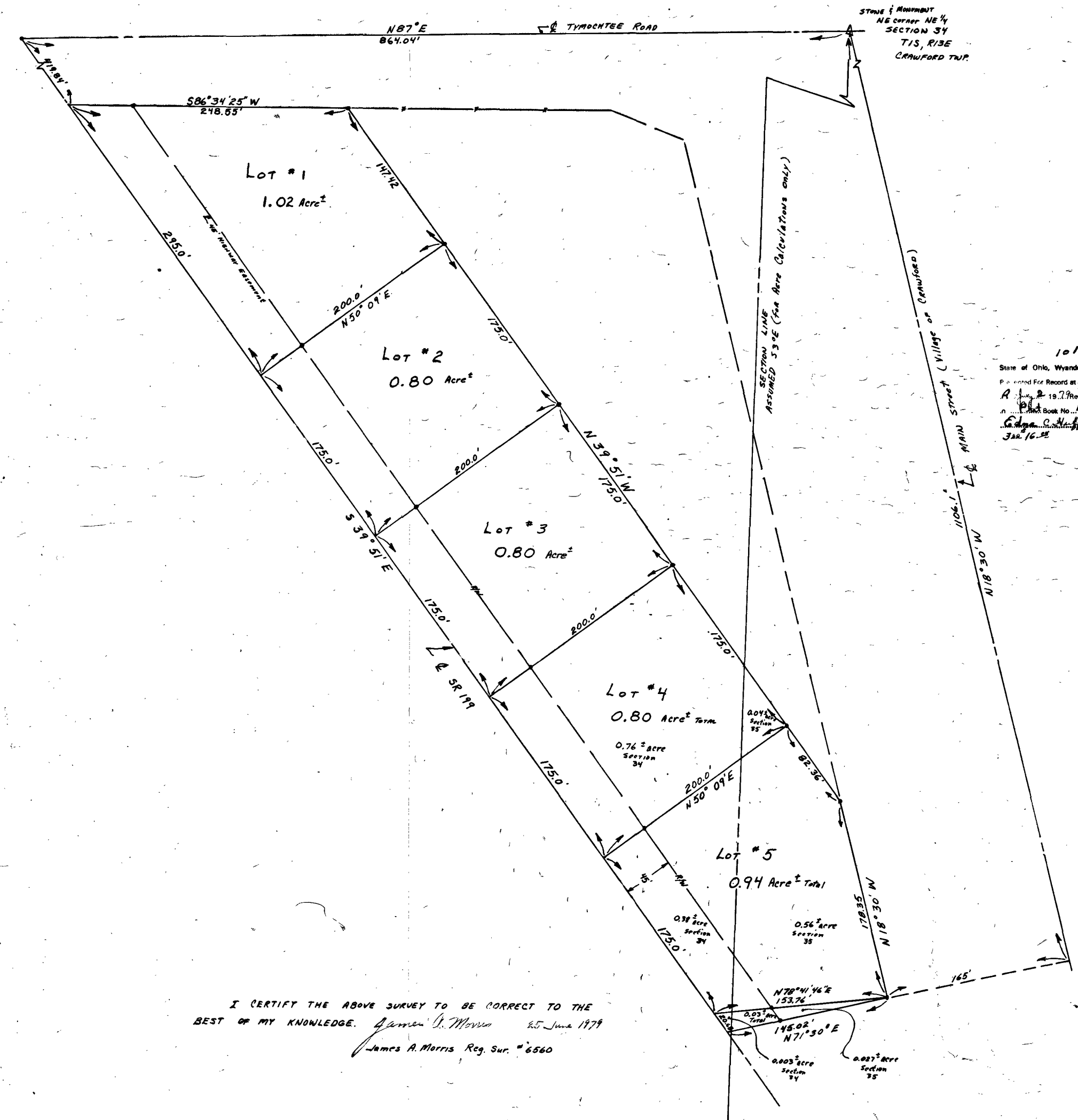

Thence S 39° 51' E for a distance of 255.0 feet;  
Thence N 50° 09' E for a distance of 200.0 feet;

Thence S 78° 41' 46" W for a distance of 153.76 feet to the point of beginning and containing in all 0.03 acre more or less subject to all highway and other legal easements of record, of which 0.001 acre is contained in Section 34 and 0.027 acre is contained in Section 35.
