**LEGAL DESCRIPTION OF A 34.678 ACRE PARCEL
FOR ROSETTA ARNOLD**

Being a parcel of land situated in part of the Southeast Quarter of Section 22, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the south quarter post of said Section 22 and the intersection of the centerlines of County Highway 103 and County Highway 64;

thence on an assumed bearing of N 90° 00' 00" E along the south line of said Section 22 and the centerline of said County Highway 64 a distance of 808.77 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 03° 14' 36" E on a line a distance of 1472.60 feet to a set iron rod, passing a set iron rod a distance of 25.04 feet;

thence N 84° 56' 48" W on a line a distance of 289.14 feet to a set iron rod;

thence N 05° 20' 10" W on a line a distance of 137.46 feet to a set iron rod;

thence N 81° 55' 15" W on a line a distance of 104.58 feet to a set iron rod;

thence N 02° 27' 30" E on a line a distance of 1010.92 feet to a set iron rod marking the east-west half section line of said Section 22;

thence S 89° 43' 23" E along the east-west half section line of said Section 22 a distance of 454.67 feet to a point marking the northwest corner of a parcel of land now or formerly owned by M. Arnold;

thence S 02° 09' 39" W along said M. Arnold parcel a distance of 660.00 feet to a set iron rod marking a corner of said M. Arnold parcel, passing a set iron rod a distance of 3.00 feet;

thence S 89° 43' 23" E along said M. Arnold parcel a distance of 423.72 feet to a set iron rod marking a corner of said M. Arnold parcel and the west line of the east half of the southeast quarter of said Section 22;

thence S 02° 09' 39" W along said M. Arnold parcel and the west line of the east half of the southeast quarter of said Section 22 a distance of 1328.31 feet to a found iron rod marking a corner of said M. Arnold parcel;

thence N 90° 00' 00" E along said M. Arnold parcel a distance of 79.53 feet to a found iron rod marking a corner of said M. Arnold parcel;

thence S 02° 09' 39" W along said M. Arnold parcel a distance of 666.60 feet to a found MAG nail marking the south line of said Section 22 and the centerline of said County Highway 64, passing a found iron rod a distance of 641.58 feet;

thence S 90° 00' 00" W along the south line of said Section 22 and the centerline of said County Highway 64 a distance of 580.14 feet to the **POINT OF BEGINNING**.

Containing in all 34.678 acres of land, more or less, of which 0.333 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
