**LEGAL DESCRIPTION FOR RALPH FAILOR
TRACT 1 – 15.600 ACRES
TOWNSHIP OF EDEN, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP 2 SOUTH, RANGE 15 EAST, TOWNSHIP OF EDEN, BEING PART OF THE SOUTHEAST QUARTER OF SECTION 10, AND BEING 15.600 ACRES OUT OF A TRACT CONVEYED TO WILLIAM R. FAILOR OF RECORD IN OFFICIAL RECORD 128, PAGE 229, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT A RAILROAD SPIKE FOUND ON THE CENTERLINE OF TOWNSHIP HIGHWAY 10 (66 FEET IN WIDTH), THE NORTHEAST CORNER OF SAID SOUTHEAST QUARTER, THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID SECTION 10, A NORTHEAST CORNER OF SAID FAILOR TRACT ACQUIRED IN OFFICIAL RECORD 128, PAGE 229, AND A SOUTHEAST CORNER OF ANOTHER TRACT CONVEYED TO WILLIAM R. FAILOR OF RECORD IN DEED VOLUME 192, PAGE 411;

THENCE SOUTH $00^{\circ}03'27''$ WEST, A DISTANCE OF 459.10 FEET WITH THE CENTERLINE OF SAID TOWNSHIP HIGHWAY 10, THE EAST LINE OF SAID SOUTHEAST QUARTER, AND AN EAST LINE OF SAID FAILOR TRACT, TO A MAG SPIKE SET AND BEING REFERENCED BY AN IRON PIN SET SOUTH $89^{\circ}49'53''$ WEST, A DISTANCE OF 33.00 FEET;


