**LEGAL DESCRIPTION FOR RALPH FAILOR  
51.200 ACRES  
TOWNSHIP OF EDEN, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP 2 SOUTH, RANGE 15 EAST, TOWNSHIP OF EDEN, BEING PART OF THE SOUTHEAST QUARTER OF SECTION 10, AND BEING 51.200 ACRES OUT OF A TRACT CONVEYED TO WILLIAM R. FAILOR OF RECORD IN OFFICIAL RECORD 128, PAGE 229, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT A RAILROAD SPIKE FOUND ON THE CENTERLINE INTERSECTION OF COUNTY HIGHWAY 44 (40 FEET IN WIDTH) AND TOWNSHIP HIGHWAY 10 (66 FEET IN WIDTH), THE SOUTHEAST CORNER OF SAID SOUTHEAST QUARTER, AND A SOUTHEAST CORNER OF SAID FAILOR TRACT, SAID RAILROAD SPIKE BEING REFERENCED BY AN IRON PIN FOUND SOUTH  $58^{\circ}31'50''$  WEST, A DISTANCE OF 38.56 FEET;

THENCE SOUTH  $89^{\circ}46'12''$  WEST, A DISTANCE OF 886.24 FEET WITH THE CENTERLINE OF SAID COUNTY HIGHWAY 44, THE SOUTH LINE OF SAID SOUTHEAST QUARTER, AND A SOUTH LINE OF SAID FAILOR TRACT, TO A MAG SPIKE SET AT A SOUTHWEST CORNER OF SAID FAILOR TRACT AND A SOUTHEAST CORNER OF A TRACT CONVEYED TO NANCY W. EYESTONE OF RECORD IN OFFICIAL RECORD 271, PAGE 61;

THENCE NORTH  $00^{\circ}06'59''$  EAST, A DISTANCE OF 990.00 FEET WITH A WEST LINE OF SAID FAILOR TRACT AND AN EAST LINE OF SAID EYESTONE TRACT, PASSING AN IRON PIN SET AT 20.00 FEET, TO AN IRON PIN SET AT A CORNER OF SAID FAILOR TRACT AND A NORTHEAST CORNER OF SAID EYESTONE TRACT;

THENCE SOUTH  $89^{\circ}46'12''$  WEST, A DISTANCE OF 439.89 FEET WITH A SOUTH LINE OF SAID FAILOR TRACT AND A NORTH LINE OF SAID EYESTONE TRACT, TO AN IRON PIN SET ON THE WEST LINE OF THE EAST HALF OF SAID SOUTHEAST QUARTER, A SOUTHWEST CORNER OF SAID FAILOR TRACT AND A CORNER OF SAID EYESTONE TRACT;

THENCE NORTH  $00^{\circ}06'59''$  EAST, A DISTANCE OF 1661.23 FEET WITH THE WEST LINE OF THE EAST HALF OF SAID SOUTHEAST QUARTER, A WEST LINE OF SAID FAILOR TRACT AND AN EAST LINE OF SAID EYESTONE TRACT, PASSING AN IRON PIN SET AT 1644.23 FEET, TO A POINT BEING REFERENCED BY SAID IRON PIN SET SOUTH  $00^{\circ}06'59''$  WEST, A DISTANCE OF 17.00 FEET, SAID POINT BEING THE NORTHWEST CORNER OF


