**LEGAL DESCRIPTION OF A 1.158 ACRE PARCEL
FOR DAVE COURTAD**

Being a parcel of land situated in part of the Northwest Quarter of Section 1, T-3-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the intersection of the west line of said Section 1 and the centerline of Township Highway 55;

thence on an assumed bearing of N 90° 00' 00" E along the centerline of said Township Highway 55 a distance of 218.00 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated N 53° 07' 11" W a distance of 41.66 feet;

thence N 53° 05' 35" E on a line and on or near the centerline of an open ditch a distance of 166.44 feet to a point, referenced by a set iron rod situated N 28° 42' 29" W a distance of 40.41 feet;

thence N 69° 29' 27" E on a line and on or near the centerline of an open ditch a distance of 304.11 feet to a set iron rod;

thence S 00° 26' 13" E on a line a distance of 206.50 feet to a found railroad spike marking the centerline of said Township Highway 55, passing a set iron rod a distance of 181.50 feet;

thence S 90° 00' 00" W along the centerline of said Township Highway 55 a distance of 419.50 feet to the **POINT OF BEGINNING**.

Containing in all 1.158 acres of land, more or less, of which 0.231 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
