**LEGAL DESCRIPTION OF AN INGRESS/EGRESS EASEMENT

Being a parcel of land situated in part of the Southeast Quarter of Section 9, T-3-S,
R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the east quarter post of said Section 9 and being
the **POINT OF BEGINNING** of the hereinafter described ingress/egress easement;

thence on an assumed bearing of S 00° 42' 41" W along the east line of said Section 9 a
distance of 340.00 feet to a point;

thence N 89° 17' 19" W on a line a distance of 24.80 feet to a point;

thence N 02° 06' 54" E on a line a distance of 40.22 feet to a set iron rod;

thence N 01° 33' 09" E on a line a distance of 260.00 feet to a set iron rod;

thence N 00° 42' 41" E on a line a distance of 40.00 feet to a set iron rod marking the
east-west half section line of said Section 9;

thence S 88° 46' 20" E along the east-west half section line of said Section 9 a distance
of 20.00 feet to the **POINT OF BEGINNING**.

Bearings are assumed and are for angular measurement only.
