**LEGAL DESCRIPTION OF A 2.222 ACRE PARCEL

Being a parcel of land situated in part of the Southeast Quarter of Section 9, Crane Township and part of the Southwest Quarter of Section 10, Pitt Township, T-3-S, R-14-E, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the east quarter post of said Section 9 and the west quarter post of said Section 10 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 00° 42' 41" W along the east line of said Section 9 and the west line of said Section 10 a distance of 747.64 feet to a set iron rod;

thence S 89° 17' 19" E on a line a distance of 147.98 feet to a set iron rod;

thence S 00° 42' 41" W on a line a distance of 327.00 feet to a set iron rod;

thence N 89° 17' 19" W on a line a distance of 236.00 feet to a set iron rod;

thence N 00° 42' 41" E on a line a distance of 327.00 feet to a set iron rod;

thence S 89° 17' 19" E on a line a distance of 53.23 feet to a set iron rod;

thence N 02° 06' 54" E on a line a distance of 447.98 feet to a set iron rod;

thence N 01° 33' 09" E on a line a distance of 260.00 feet to a set iron rod;

thence N 00° 42' 41" E on a line a distance of 40.00 feet to a set iron rod marking the east-west half section line of said Section 9;

thence S 88° 46' 20" E along the east-west half section line of said Section 9 a distance of 20.00 feet to the **POINT OF BEGINNING**.

Containing in all 2.222 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
