Situate in the Northwest Quarter of Section 21, Town 1 South, Range 13 East, Village of Carey, Wyandot County, Ohio and being a part of Lot 31 of the Revision of Lots 204-251 in Snyder Park as shown on Plat Cabinet A, Slides 421, on record as of the date this survey was prepared, in Official Record 273, Page 1929 and Official Record 273, Page 1931 (TOD), of the Wyandot County, Ohio Recorder's Office and lying on the left side of the centerline of right-of-way of Yule Tree Drive as shown on WYA-CAREY SAFE ROUTES TO SCHOOL PHASE 2 right-of-way plans on file at the Village of Carey, Ohio, and being more particularly described as follows:

Beginning at an iron pin found at the southeast corner of said Lot 31 and being the northeast corner of Lot 30 of said Revision of Lots 204-251 in Snyder Park and being on the west right-of-way line of Yule Tree Drive and being the **PLACE OF BEGINNING** of the parcel herein described with said point and being 25.00 feet left of and perpendicular to centerline of right-of-way Station 27+94.05;

Thence **South 89°-52'-46" West, 2.00** feet, along the south line of said Lot 31 and the north line of said Lot 30 to an iron pin with cap set on the new west right-of-way line of Yule Tree Drive and being 27.00 feet left of and perpendicular to centerline of right-of-way Station 27+94.05;

Thence **North 00°-07'-14" West, 20.95** feet, along the new west right-of-way line of Yule Tree Drive to an iron pin with cap set and being 27.00 feet left of and perpendicular to centerline of right-of-way Station 28+15.00;

Thence **North 89°-52'-46" East, 2.00** feet, along the new right-of-way line of Yule Tree Drive to an iron pin with cap set on the existing west right-of-way line of Yule Tree Drive and being 25.00 feet left of and perpendicular to centerline of right-of-way Station 28+15.00;


The above described area is part of currently assigned Wyandot County Auditor's Parcel Number 10-1805-0000-00.
