

LEGAL DESCRIPTION

3.722 Acres
Parcel D
Parcel Split

Situated in the Township of Sycamore, County of Wyandot, State of Ohio and being part of the NW1/4 of Section 29, T1S, R15E, also being part of a 4.084 acre tract of land conveyed to William O'Flaherty, as described in Book 237, Page 2438 of the Wyandot County Official Records, a tract of land bounded and described as follows;

Commencing at the W1/4 corner of said Section 29, lying on the centerline of County Highway 134;
thence along the west line of the NW1/4 of said Section 29, also being the centerline of said County Highway 134, N00°21'42"W, a distance of 929.78 feet to a mag nail found marking the northwest corner of a 44.0005 acre tract of land conveyed to Rodney R. Stover, Trustee as described in Book 283, Page 506 of the Wyandot County Official Records;

thence along the north line of said 44.0005 acre tract, N89°31'27"E, a distance of 394.57 feet to an iron pin set marking the Point of Beginning of the herein described tract;

thence from the above described Point of Beginning and along the west line it's southerly extension of a 5.000 acre tract of land conveyed to Sarah Ann Curlis, as described in Book 237, Page 2436 of the Wyandot County Official Records, N00°21'42"W, a distance of 457.76 feet to a 5/8" iron pin found with VBK cap marking a westerly corner of said 44.0005 acre tract, passing over a 5/8" iron pin found with VBK cap at 40.00 feet and an iron pin set at 316.00 feet;

thence along the westerly side of said 44.0005 acre tract for the following 10 courses:

- 1) thence, N89°43'34"E, a distance of 360.34 feet to a 5/8" iron pin found with VBK cap;
- 2) thence, N18°37'42"E, a distance of 61.14 feet to a 5/8" iron pin found with VBK cap;
- 3) thence, N75°07'29"E, a distance of 151.75 feet to a 5/8" iron pin found;
- 4) thence, N89°31'27"E, a distance of 53.74 feet to a 5/8" iron pin found with VBK cap;
- 5) thence, S00°21'42"E, a distance of 178.90 feet to a bent 5/8" iron pin found with VBK cap;
- 6) thence, S89°11'48"W, a distance of 199.27 feet to a bent 5/8" iron pin found;
- 7) thence, S00°21'42"E, a distance of 159.38 feet to a bent 5/8" iron pin found;
- 8) thence, S89°31'27"W, a distance of 200.28 feet to a 5/8" iron pin found with VBK cap;
- 9) thence, S08°14'27"W, a distance of 215.06 feet to a 5/8" iron pin found;
- 10) thence, S89°31'27"W, a distance of 149.17 feet to the Point of Beginning, containing 3.722 acres of land, more or less, of which 0.000 acres lie in the road right-of-way, subject however to all legal highways and prior easements of record.

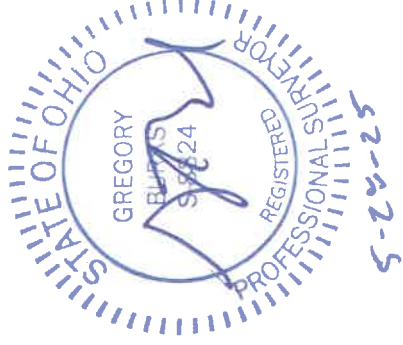
